Parent Right to Know: As a parent of a student at a Title 1 served school, you have the right to know the professional qualifications of the classroom teachers who instruct your child. Federal law allows you to ask for certain information about your child's classroom teachers and requires us to give you this information in a timely manner. Specifically, you have the right to ask for the following information about each of your child's classroom teachers: Whether the teacher has met the State qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction; Whether the teacher received an emergency or conditional certificate through which state qualifications are waived; What undergraduate or graduate degrees the teacher holds, including the field of discipline of the certification or degree; Whether the child is provided services by paraprofessionals and if so their qualifications.
